
### The Keynote Speakers



#### Frank Deford

Among the most versatile of writers, Frank Deford's work has appeared in virtually every medium. In magazines, he has returned to *Sports illustrated*, where his byline originally appeared from 1962 through 1989. On radio, he may be heard as a commentator every Wednesday on *Morning Edition* on National Public Radio and, on television, he is a regular correspondent on the HBO show, *RealSports With Bryant Gumbel*.

As a journalist, Deford was most recently presented with the National Magazine Award for profiles for his story on Bill Russell. He has been elected to the Hall of Fame of the National Association of Sportscasters and Sportswriters. Six times Deford was voted by his peers as U.S. Sportswriter of The Year. Deford has been presented with a Christopher Award and journalism Honor Awards from the University of Missouri and Northeastern University. *The Sporting News* has described Deford as "the most influential sports voice among members of the print media," and the magazine GQ has called him, simply, "the world's greatest sportswriter." In broadcast, Deford has won both an Emmy and a George Foster Peabody Award.

#### **Bruce Rendina**

Mr. Bruce Rendina is Chairman and Chief Executive Officer of The Rendina Companies. In 1987, Mr. Rendina co-founded DASCO Companies, which became the largest healthcare real estate developer in the United States during Mr. Rendina's tenure as Chairman and CEO. Developments have included medical office, retail, and residential space. Rendina Companies was subsequently formed in 1998. During the last 20 years, through these companies Mr. Rendina has structured, developed, constructed and negotiated the sale of real estate transactions valued in excess of \$2 billion. In 1997, Mr. Rendina was named Ernst & Young's Entrepreneur of the Year.

Previously, Mr. Rendina was with the international accounting firm of PricewaterhouseCoopers from 1975 to 1986, where he held the position of Regional Director—Southeast United States. From 1986 to 1987, Mr. Rendina was the Executive Vice President of a large publicly traded real estate development company. Mr. Rendina is a licensed securities principal. He graduated from Florida State University with a Bachelor of Science degree with a major in accounting.


